Following the above, GLM will, in due course, lodge an office copy of the sealed High Court Order with the Registrar of Companies pursuant to subsection 116(6) of the Act ("**Lodgement**"). The Privatisation will become effective upon the Lodgement ("**Effective Date**").

For the avoidance of doubt, the Effective Date shall be on the same day as the Entitlement Date, which will be announced in due course.
