- 1. Each of the Resolutions to be put to the vote of members at the 49th AGM (and at any adjournment thereof) will be voted on by way of a poll.
- 2. Please insert the total number of shares held by you. If you have shares entered against your name in the Depository Register (maintained by The Central Depository (Pte) Limited), you should insert that number of shares. If you have shares registered in your name in the Register of Members (maintained by or on behalf of the Company), you should insert that number of shares. If you have shares entered against your name in the Depository Register and shares registered in your name in the Register of Members, you should insert the aggregate number of shares. If no number is inserted, this proxy form will be deemed to relate to all the shares held by you.
- 3. (a) A member who is not a relevant intermediary is entitled to appoint not more than two proxies to attend, speak and vote at the 49th AGM. Where such member's proxy form appoints more than one proxy, the proportion of the shareholding concerned to be represented by each proxy shall be specified in the proxy form.
 - (b) A member who is a relevant intermediary is entitled to appoint more than two proxies to attend, speak and vote at the 49th AGM, but each proxy must be appointed to exercise the rights attached to a different share or shares held by such member. Where such member's proxy form appoints more than two proxies, the number and class of shares in relation to which each proxy has been appointed shall be specified in the proxy form.
 - "Relevant intermediary" has the meaning ascribed to it in Section 181 of the Companies Act 1967.
- 4. A proxy need not be a member of the Company. A member may choose to appoint the Chairman of the 49th AGM as his/her/its proxy.
- 5. A member who wishes to appoint a proxy(ies) must complete the proxy form and submit the proxy form to the Company in the following manner:
 - (a) if submitted electronically, be submitted via email to the Company's Share Registrar at main@zicoholdings.com; or
 - (b) if submitted personally or by post, be lodged at the office of the Company's Share Registrar, B.A.C.S. Private Limited, 77 Robinson Road, #06-03 Robinson 77, Singapore 068896

in each case, must be lodged or received (as the case may be) by 2.30 p.m. on 20 October 2025, being at least 72 hours before the time appointed for holding the 49th AGM.

- 6. The proxy form must, if submitted personally or by post or electronically via email, be signed under the hand of the appointor or of his/her attorney duly authorised in writing. Where the proxy form is signed on behalf of the appointor by an attorney, the letter or power of attorney or a duly certified copy thereof must, if the proxy form is submitted personally or by post, be lodged with the proxy form or, if the proxy form is submitted electronically via email, be emailed with the proxy form, failing which the proxy form may be treated as invalid. Where the proxy form is executed by a corporation, it must, if submitted by post or electronically via email, be executed either under its seal or under the hand of its attorney or a duly authorised officer.
- A corporation which is a member may also authorise by resolution of its directors or other governing body, such person as it thinks fit to act as
 its representative at the 49th AGM, in accordance with Section 179 of the Companies Act 1967.
- 8. Completion and return of this proxy form shall not preclude a member from attending and voting in person at the 49th AGM. If a member attends the 49th AGM in person, the appointment of a proxy or proxies shall be deemed to be revoked, and the Company reserves the right to refuse to admit such proxy or proxies to the 49th AGM.
- 9. The Company shall be entitled to reject the proxy form if it is incomplete, improperly completed, illegible or where the true intentions of the appointor are not ascertainable from the instructions of the appointor specified in the proxy form (including any related attachment). In addition, in the case of a member whose shares are entered in the Depository Register, the Company may reject any proxy form lodged if the member, being the appointor, is not shown to have shares entered against his/her/its name in the Depository Register as at 72 hours before the time appointed for holding the 49th AGM, as certified by The Central Depository (Pte) Limited to the Company.
